

**EVENT VENDOR CONCESSION CONTRACT**

The parties to this contract are the Cherokee County Fair Association (hereafter name "host" and \_\_\_\_\_ (hereafter named "vendor")

Whereas, the host is hosting an event know as the Cherokee County Fair to occur on July \_\_, 20\_\_ through July \_\_, 20\_\_ beginning at 9:00 AM and has the right to license concessions at and during the event, and whereas, the vendor desires to vend food and Coke products at and during the event, and

Whereas, the vendor has paid the host the sum of \$ \_\_\_\_\_ for a license to vend at and during said event. This vendor fee will be due and payable to the Cherokee County Fair and must be paid in full BEFORE setting up concessions on the fairgrounds and opening for business.

Now, therefore, the parties agree as follows:

- Vendor shall have access to the location agreed upon by the parties no less than 24 hours before the event's commencement for the purpose of setting up Vendor's vending station, goods and other things necessary and reasonable to vending at the event's location.
- Vendor shall not vend goods or services other than those described herein and during the event without the host's written consent.
- Vendor agrees to **only vend COKE products** on fair grounds and to order such products from Chesterman & Company. Contact Rod Keleher at 712-229-0398.
- VENDORS ARE EXPECTED TO UNLOAD SUPPLIES AND IMMEDIATELY REMOVE VEHICLES FROM FAIRGROUNDS TO ASSIGNED PARKING AREA
- **If more than (1) one 50 amp outlet is required per space, there will be an additional charge of \$50.** Arrangements must be made with the fair board representative who signs this contract.
- Vendor's staff may announce the availability of the goods to be vended only while they are in the confines of the vendor's location. (No hawking in the stands or grounds)
- Vendor's staff **SHALL** be clothed and groomed in a clean, neat fashion and conduct themselves in an orderly fashion. No weapons are allowed onto the fairgrounds.
- No loud music, noise, or sound amplification devices shall be used by the vendor's staff at the location
- Vendor shall have access to the location for up to 24 hours after the event's conclusion at 6:00 PM on the above noted end date of the Cherokee County Fair in order to dismantle and remove all paraphernalia brought to the location by the vendor. Vendor **SHALL** leave the location clean of trash, grease and other byproducts of the vendor. The vendor shall leave the location in the condition, if not better, than before the vendor occupied it.
- Vendor hereby agrees to indemnify and hold harmless the host against any damages or claims that may arise in connection with the vendor's presence at the event and vendor's activities of any kind.
- Vendor agrees to vend their products until the conclusion of the fair. Vendor agrees **NO WEAPONS WILL BE BROUGHT ONTO THE FAIRGROUNDS.**
